Arch Carts said they charge \$5.00 per person Commission Satz said that way fair and Chairman McNutt agreed. Director Klein said that the police department has been complaining about the illegal carts and asked him to do something about it. Commissioner Rudawsky asked about Arch Carts insurance after reviewing the insurance the commissioner agreed Arch Carts has enough coverage. Commissioner Satz asked if they get a sticker for their carts so that the public knows they are regulated Director Klein said yes and the drivers are licensed with MTC also.
